Managing a high volume of grants

The Legal Aid Commission of Tasmania must maintain an outstanding level of service delivery to its customers by effectively managing a large number of grants of legal aid. For the 2006-2007 financial years the Commission provided 20,822 grants of legal aid, with an additional 7,000 cases of providing legal advice in clinic sessions, and they offered over 25,000 individual's legal advice over the telephone.

These high volumes of activity require a robust matter management system that can automate 'everyday' tasks to streamline the delivery of services. The Commission also required the development of an integrated grants and case management system to capture and report accurate data at file level. The system needed to automate the processing of grants and associated payment for the work completed. LA Office's underlying architecture was becoming dangerously complex and at a stage where it was difficult to safely enhance its performance. Therefore the replacement system needed to be tailored to the Commission's specific requirements.
